NOTIFICATION

The Jammu & Kashmir State Open School, a subsidiary of J&K State Board of School Education, is going to start functioning from both the divisional offices located at Rehari Colony Jammu and old campus Lal Mandi, Srinagar through a network of 22 selected Government Schools, one from each district. However the accreditation facilities shall be extended to some other Govt. and Private Institutions in future after successful establishment of JK, SOS. The State Open School is going to cater to the educational needs of those who are unable to get entry into the formal system of education due to one reason or the other. Such candidates include school drop-outs, older persons, persons in employment to enhance their chances of promotion, disadvantaged groups, failures from the formal system of education etc. The courses of study for open schooling are tailor made and are different from the ones which are in vogue for formal education.

The candidates desirous of completing their secondary school examination (10th Class) through JK SOS shall have to fulfill the following eligibility criteria.


- a) Should have attained the age of 14 years on or before 1.11.2013. However there will be no upper age limit.
- b) Should have passed 8th Class examination from any recognized Institution.

The application forms along with prospectus shall be available at the Office of the Principals/Headmasters of the above mentioned Institutions on all working days from January 01, 2014 to January 25, 2014 during office hours against a payment of Rs.100.00 in the form of a bank draft drawn in favour of "Chairman, Jammu and Kashmir State Board of School Education", payable at Srinagar. There are limited number of seats at each Accredited Centre and therefore the selection of the candidates will be purely on **first come , first serve basis** subject to fulfillment of the eligibility criteria. Each Accredited Centre shall admit a maximum of 160 candidates for the current academic session to appear in 10th class examination to be conducted by JK, SOS as per the schedule to be notified separately.

Moreover, the application forms duly completed in all respects shall be accompanied by a Bank draft of Rs 2630/- (including Examination fee and other fees) drawn in favour of Chairman BoSE , payable at Srinagar and be deposited in the respective Accredited Centres.
