**TERMS & CONDITIONS**

1. The tenderer/bidder will quote the rates on the basis of each KG for lifting of used Answer books lying in Kashmir Division of this organisation inclusive of all Taxes.
2. **NOTE: - *The rate quoted by the Bidder / Tenderer should be above the minimum reserve price mentioned in the NIT No: 85-CF of 2018 Dated: 28-09-2018.***
3. Each page of the tender document should bear the signature of the authorized signatory with seal.
4. The approved tenderer / bidder shall deposit the cost of lifting of Used Answer Books on daily basis of weighed lifted material.
5. The lifting / weighing process will be supervised by a Committee duly constituted by the BOSE authorities.
6. If the approved tenderer/ bidder fails to start lifting the said material within 05 days from the date of issuance of Job / allotment order, earnest money so deposited with the BOSE by him shall be forfeited. The process of lifting the used material should be completed within 07 days from the date of issuance of the order, failing which the discretion lies on the competent authority of BoSE to impose penalty as deemed fit and proper and also take any other action as required by them.
7. The successful bidder shall deposit Rs.50,000/- (Rupees Fifty Thousand) only in the shape of bank draft pledged to Secretary, J&K State Board of School Education, New Board Campus Bemina Srinagar as a Security deposit.
